

**VIOC SURVEY SWEEPSTAKES
Official Rules and Regulations**

1. **PARTICIPATION CONSTITUTES ACCEPTANCE OF RULES.** Participation in this Sweepstakes constitutes entrant's full and unconditional acceptance of these Official Rules and the decisions of the Sponsor.
